Commercial Break-and-Enters in North Scarborough | TPS would like to make public aware of a steady increase in a series of commercial Break-and-Enters in North Scarborough. Suspects(s) would enter the commercial premise by damaging the front door, mainly in the early morning hours before the businesses are open, and target cash registers, tip jars and any other place they believe cash is being hidden. Business owners are advised to not leave tip jars or cash in the registers after closing time and to display "No Cash On Site" signs. BLACK HISTORY MONTH

Every February, we celebrate the contribution of the African-Canadian community in the City of Toronto through a series of events - https://www.toronto.ca/explore-enjoy/history-art-culture/black-history-month/. In honour of Black History Month, I would like to acknowledge the prominent figures who have done so much for the betterment of our community.

William Andrew (Bill) While, III, OC (1915 - 1981), was a Canadian musician, song writer, and humanitarian and social justice activities. He was the first Black Canadian to run for federal office in Canada during the 1948 election, and was appointed & invested into the Order of Canada in 1971 for his contribution to better relations and understanding between people of different racial background. His numerous recognitions also include Scarborough Citizen of the Year and Top 200 citizens in 200 years. Mr. White was a long-time Scarborough resident and still has family living in the CD Farquharson area.

Alvin Curling is a Jamaican-born Canadian politician who served as MPP in the riding of Scarborough and became the first Black Canadian to hold a cabinet-level position in Ontario after he was appointed as the Minister of Housing in 1985. He served many roles during his time at the provincial legislature, including Minister of Skills Development in 1987 and Speaker of the Legislature in 2003. In 2005, he accepted a diplomatic posting as Canada's ambassador to the Dominican Republic. Mr. Curling was made a Member of the Order of Ontario in 2014 and remains active in the community. You may have spotted a street called Alvin Curling Crescent, and yes, it is named after him.

I am sure there are many other local heroes who have contributed to our community and welcome your input in acknowledging them!

I also encourage you to check out **Tropicana Community Services**, located at 1385 Huntingwood Dr, a centre that has been providing great resource and services to youths and families.

WASTE REDUCTION COMMUNITY GRANTS

Have an innovative idea to reduce waste in your community? Grants of up to \$25,000 are available to support innovative community-based efforts to reduce residential waste and increase participation in Toronto's waste diversion programs. Priority for funding will be given to projects that reduce waste in apartments and condos. Examples of projects that could be eligible include waste education and engagement programs and initiatives that align with Toronto's Long Term Waste Management Strategy, such as the repair, exchange, swapping and sharing of goods. TORONTO REAL ESTATE BOARD - SIGN BY-LAW INFRACTION COMPLAINT PROCESS

Toronto Real Estate Board (TREB) has worked with the City in reviewing sign by-laws, and is implanting a formal process which will accept complaints from the public and Realtors about sign by-law infractions by realtors. Complaints regarding a breach of a municipal sign by-law will be reviewed by TREB and should include the following information:

- 1. Full name of person making complaint
- 2. Date & time the signage was seen
- 3. Location of the signage (i.e., street intersection)
- 4. The property the signage relates to or the apparent absence of a listing that corresponds with the signage
- 5. If possible, a clear photograph of the signage that identifies the Member(s) that is also date stamped.

PARKLAND STRATEGY PHASE 2 SELF-GUIDED DISPLAYS

Following the approval of Parkland Strategy's Phase 1 Report (http://app.toronto.ca/tmmis/viewAgendaItemHistory.do?item=2017.EX29.3) at the November 2017 Executive Committee meeting, work has been underway on the second phase. This is a 20-year plan that will guide decision-making and prioritization of investment of Toronto's parks, including acquisition of new parks, improvements and connections to existing parks. A series of self-guided displays highlighting the findings and analysis from the first phase will be available at Scarborough Civic Centre from February 19 to 23, 2018.
